

Chelsea Travel AmaSEAng Raffle

Per DTI Fair Trade Permit No. FTEB – 221037 Series of 2025



Who can join the raffle?

The raffle is open to all Chelsea Group (Starlite Ferries, SuperCat, Trans-Asia) passengers who will book online via the Chelsea Travel App (<u>https://www.chelseatravel.ph/</u>).

- 1. All paying passengers, from 4 years old and above, may join.
- 2. All employees of Chelsea Group and agents of Starlite, SuperCat, Trans-Asia, and their relatives up to the 2nd degree of consanguinity or affinity (e.g. parents, children, grandparents, siblings, grandchildren, spouse, parents-in-law, daughter/son-in-law) are disqualified from joining this Raffle.

How to Join the Raffle?

- 1. Be a member of Chelsea Loyalty (<u>https://bit.ly/ChelseaLoyalty</u>).
- 2. Book a trip via Chelsea Travel App (https://www.chelseatravel.ph/).
- 3. Answer the survey about your experience in using the Chelsea Travel App. Make sure to provide your **complete home address** to be eligible for the raffle draw.
 - a. Should you refuse/skip to answer the survey, your ticket number will not be eligible for the raffle draw.
 - b. Should you accidentally skip answering the survey, an email will be sent to you so you can have a chance to answer the survey and join the raffle.
- 4. Your ticket number will automatically be your entry and be part of the raffle draw.
- 5. Campaign runs from April 8, 2025 to August 31, 2025.

How many entries do I get if I book several times?

For every successful single booking that you make, you get an entry. Example: If you book twice, you will get two ticket numbers and you will have two entries in the raffle draw.

In the case of Group Booking, all passengers under the group booking will be eligible for a raffle entry.



How will I know if my entry is valid?

You must wait for the confirmation via email and SMS within 24 hours from booking/ entry submission.

When and where will the raffle draw be held?

The Raffle Draw will be conducted on September 12, 2025 (Friday), 1:30 pm at the Chelsea Logistics Manila Office, 18F Conference Room, UDENNA Tower, Rizal Drive corner 4th Avenue, Bonifacio Global City, Taguig City. This will be witnessed by Chelsea Logistics Representative/s, and DTI Representative/s

When will the winners be announced?

The announcement of winners will be on October 8, 2025 (Wednesday).

What are the prizes?

- 1. There will be one (1) grand prize of Thirty Thousand Pesos (PhP 30,000) cash.
- 2. There will be 110 consolation prizes:
 - a. 100 winners of 2 round trip tickets from any shipping line of choice (Starlite Ferries, SuperCat, and Trans-Asia)
 - b. 10 winners of PhP 3,000 cash

How will I know if I won in the Raffle?

Winners will be chosen via a system-generated randomizer (Microsoft Excel). Announcement of winners will be published via Chelsea Logistics' social media channels on October 8, 2025 (Wednesday)

Winning passengers will also be notified via text, call and snail mail from an official Chelsea Logistics Representative to verify their details. Prizes must be claimed within sixty (60) days from receipt of notification from Chelsea Logistics otherwise the same will be forfeited.

How many times can I win in the Raffle?

You can only win once in the raffle. If you happen to win both the grand prize and a consolation prize, the prize of greater value will be awarded to you. Having more than one entry increases your chances of winning.

How can I claim my prize?

- 1. The winner should present a valid government-issued ID bearing the exact name indicated on the booking.
- 2. The awarding of prizes will be done onsite at the nearest Chelsea Logistics, Starlite Ferries, SuperCat, or Trans-Asia Office.



3. Claiming of prizes is within sixty (60) days upon receipt of notification from Chelsea Logistics.

I cannot personally claim my prize. Can I send my representative to claim it?

Yes, the winner can send a representative. The representative should bring the following:

- a) Chelsea's notification message to the winner (sms, e-mail or snail mail)
- b) The winner's email to Chelsea Logistics authorizing the representative
- c) Special Power of Attorney
- d) Photocopy of winner's valid government ID
- e) Photocopy of representative valid government-issued ID

If the grand winner is a minor (aged 4 to 17 years old), the process for claiming the raffle prize involves the following:

- a) Chelsea's notification message to the winner (sms, e-mail or snail mail)
- b) Parental or Guardian Consent: The minor's parent or legal guardian must provide written consent to claim the prize on behalf of the minor.
- c) Valid Identification: Both the minor and their parent or guardian should present valid government-issued IDs for verification. In absence of government-issued ID, any of the following can be presented: school ID, PSA birth certificate, baptismal certificate, passport, national ID or barangay certificate, or any ID approved by the Department of Trade and Industry (DTI).
- d) (Optional) Proof of Relationship: Documents such as a birth certificate or legal guardianship papers may be required to establish the relationship between the minor and the guardian.

Terms & Conditions

- 1. The "Chelsea Travel AmaSEAng Raffle" is open to all Chelsea Group (Starlite Ferries, SuperCat, Trans-Asia) paying passengers, from 4 years old and above.
- 2. All employees of Chelsea Group and agents of Starlite, SuperCat, Trans-Asia, and their relatives up to the 2nd degree of consanguinity or affinity (e.g. parents, children, grandparents, siblings, grandchildren, spouse, parents-in-law, daughter/son-in-law) are disqualified from joining this Raffle.
- 3. Only those who booked via the Chelsea Travel App (<u>https://www.chelseatravel.ph/</u>) with an official ticket number will earn a raffle entry.
- 4. Campaign period is from April 8, 2025 to August 31, 2025.
- 5. A passenger must use his/her complete name that matches with any valid government identifications in creating a profile in the Chelsea Travel App when purchasing a ticket.



- 6. There is no limit to the number of raffle entries a passenger may have. Each unique ticket number serves as the passenger's valid raffle entry/entries. An SMS/email notification will be sent to confirm the validity of the raffle entry.
- 7. In the case of Group Booking, all passengers under the group booking will be eligible for a raffle entry.
- 8. Only boarded or fulfilled trips as of September 8, 2025, 11:59 PM (Monday) will be included in the raffle draw.
- 9. Participants are limited to winning only once. If an individual wins both the grand prize and a consolation prize, the prize of greater value will be awarded to them.
- 10. All winners are subject to verification.
- 11. The passenger is required to take full responsibility and liability for the information provided by them under the terms and conditions of the Chelsea Travel AmaSEAng Raffle. Chelsea Logistics reserves the right to verify the information provided by the participants. In the event such verification is not accomplished to the satisfaction of Chelsea Logistics, the passenger will be disqualified from the raffle with prior DTI approval.
- 12. A DTI Representative will be invited to draw the raffle winners.
- 13. The Raffle Draw will be conducted at the Chelsea Logistics Manila Office, 18F Conference Room, UDENNA Tower, Rizal Drive corner 4th Avenue, Bonifacio Global City, Taguig City. This will be witnessed by Chelsea Logistics Representative/s, and DTI Representative/s. The awarding of prizes will be done onsite at the nearest Chelsea Logistics, Starlite Ferries, SuperCat, or Trans-Asia Office.
- 14. Announcement of raffle winners will be done via registered e-mail, SMS, social media, Chelsea Travel App, and other channels on October 8, 2025 (Wednesday).
- 15. Passengers hereby consent to the use of their name and mobile number provided to Chelsea Logistics for the purposes of verifying their identity, announcing winners' names via social media posts, sending prizes, and for marketing purposes. Marketing refers to email and SMS communications, including but not limited to trip schedules, sales promotions, special discounts, loyalty rewards, route/service/product launches, magazine issues, holiday offers, and exclusive deals or promotions from partner merchants.

- 17. Eligible Chelsea Logistics passengers will receive an SMS notification from Chelsea Logistics on the validity of entry/ies. Passengers will also see ads via Chelsea Group's official Facebook Pages and Instagram pages and other official channels promoting the campaign.
- 18. Promo period is from April 8, 2025 9:00 AM until August 31, 2025 11:59 PM only. Any transactions beyond the promo period will not be included.
